WHAT IS AN ADA JOB ACCOMODATION?

If you are having difficulties performing your job due to a disability, you may qualify for an accommodation under the ADA (Americans with Disabilities Act) Benefit. A reasonable accommodation is any work environment change to help a disabled individual perform their job duties. An accommodation may take a variety of forms, including:

- Additional time off requested, due to ongoing medical care needed after FMLA (Family Medical Leave Act) 12 week of job protection has ended
- Modified work arrangements
- Worksite accommodations such as a standup desk

HOW CAN I REQUEST AN ADA JOB ACCOMODATION?*

Endeavor's ADA benefits are administered in partnership with New York Life Leave Solutions. This means that you must contact New York Life Leave Solutions to request an accommodation. New York Life will review the request and determine the appropriate course of action including proactive vocational support and suggestions for potential accommodations for the Endeavor to evaluate and approve. A Vocational Coach will guide you through the ADA process as follows:
